

Contraventions

provided by the Government Decision nr.194/2002 regarding the situation of the foreign citizens in Romania, republished

1. The neglect by the foreigner of the obligations of leaving the Romanian territory after the expiration date of the residence permit, as mentioned in art.11

ART.11

- (1) The foreigners temporary established by legal ways in Romania, can stay on the Romanian territory only until the expiration date of the permit, established by the visa or, depending on the situation, by the residence permit.
- (2) The foreign citizens who don't have the obligation of obtaining a visa in order to enter the Romanian territory are allowed to stay 90 day at the most, within 6 months, from the first day of entrance in Romania. In the cases in which, through the international conventions or normative regulations in the unilateral visa character is abolished, the visa regime is not

(art.135 lett. e), (i, ii, iii), combined with art.134, pct.2 referring to art.11, as follows:

- i. from 400 lei to 700 lei in the case of a residence for 30 days at the most, after the suspension of the residence permit;
- ii. from 600 lei to 1000 lei, in the case of a residence for 60 days at the most, after the suspension of the residence permit;
- iii. from 600 lei to 1200 lei, in the case of a residence of over 60 after the suspension of the residence permit.

2. The inobservance by the foreigner of the obligations provided by art, 13 align. (2).

ART.13

(2) The foreign citizen who is changing the domicile or residence has, as within 15 days from the displacement to the new address, to present itself to the Romanian Office for Immigrations, in order to be taken into account and to make the necessary changes in the identity card.

3.The unpronouncement of the information provided by art.13, align (1) and (3), in the terms provided by art. 13 align (4).

The information of the authorities regarding the changes in the situation of the foreigner

(1) During the residence in Romania, the foreigners have the obligations of declaring to the territorial Office for Foreigners who granted their residence permit, the followings:

- a) any modification intervened in their personal situation, especially the changes of the citizenship, the closure, decomposition or annulment of a marriage, the birth of a child, the decease of a member of the family found on the Romanian territory;
- b) any modification intervened in the field of employment;
- c) the loss, the prolongation of the availability or the change of the crossing the state border document;

(3) The theft or the loss of the crossing the state border documents will have to be declared to the territorial Police Department.

(4) The declarations provided by align (1) have to be made within 30 days, and those provided by align (3), within 48 hours.

Attention!!! The criminal can pay half of the minimum value of the ticket provided by the law within 48 hours from the receiving of the statement of contravention.

4. The inobservance of the deadlines of the prolongation request of the residence permit, provided by art.51, align. (1):

Art.51

(1) The prolongation requests of the residence permit have to be deposed personally by the solicitant, with at least 30 days before the expiration date for which the residence was approved, at the territorial Romanian Office for Immigrations, from the place of residence.

5. The unfulfillment by the foreigners of the obligations provided by art.50. align.(3)

ART.50 align (3)

(3) The foreigners have the obligation, after the expiring of the documents, provided by align (2), lett. c), f) and g), to take the necessary measures to extend the availability or renewal of the documents.

==Al.(2)==

c) poses an available travel document;

f) poses the proof a legal living space ;

g) have the proof of the health assurance.

(6) The unfulfilment of the obligation of the foreigner regarding the residence permit, provided by art.108, align. (2), regarding the card of residence, provided by art.116 align.(4), as well as the non-show of the traveling documents, in the case of the foreigners found in Romania in a base of a visa or in terms of international conventions or normative regulation by which the unilateral visa regime is abolished;

ART.108

(2) The owner of the residence permit has the obligation of having upon itself, with a permanent character, the documents, of not alienate the documents and of showing them to the competent authorities every time the documents are required.

ART.116 - - The regime of the card of residence

(4) Any modifications, additions or mentions, other than those provided by the laws, written on the documents provided by art. 114, are forbidden and draw upon themselves the nullity of the mentioned documents.

Attention!!! In this case, the criminal can pay half of the minimum value of the ticket, provided by the law, within 48 hours from the receiving of the statement of contravention.

7. The unfulfilment of the terms for the deposit of the request for the renewal of the residence permit, provided by art.110, align.(4);

ART.110

(4) For the renewal of the permanent residence permit, the solicitant has to make, with at least 30 days before he expiring of the documents, a written request accompanied by a few documents proving the owning of a living space , at the declared address on the Romanian territory.

(100-500 lei, art.135, lett.a), combined with art.134, pct.12, referring to art.110, align. (4)

8. The unfulfilment of the terms of declaring the theft, the loss or deterioration or destroy of the residence permit, provided by art.112, align. (1);

ART.112

(1) The owner of the residence permit has the obligation of announcing the territorial Romanian Office for Immigration who gave the document, the theft, the loss, the deterioration or the destroy of the residence permit, in 5 days at the most, since the happening of one of these situations.

(100-500 lei, art.135, lett. a), combined with art.134, pct.13, referring to art.112, align. (1)

9. The retaining of the crossing the border state document of another foreign citizen or of another residence permit by unauthorized persons.

(200 - 300 lei, art.135, lett.c. c), combined with art.134, pct.15

10. The facilitation, by any means, of the illegal residence of the foreign citizens on the Romanian territory.

(200 - 300 lei, art.135, lett.c. c), combined with art.134, pct.16
