Description of vacant position	<p><i>The vacant position of assistant professor, no. 32 in the Organizational Chart of the Department of Foreign Languages for Specific Purposes (DLSS), includes English for Specific Purposes practical courses, BA level (for students of the Faculty of European Studies).</i></p> <p>The specialized English language course (English for Specific Purposes) aims to consolidate the knowledge acquired by students in previous years of formal instruction and to complete it with new, field-specific one, appropriate for the European Studies domain. The main objective of the course is the processing of specialized texts both from the point of view of vocabulary (specialized terminology) and from the point of view of recurring grammatical structures. The second objective of the course is the development of (written and oral) individual study and communication skills for socio-professional integration in the foreign and domestic labor market.</p> <p>The candidate must fulfil all the requirements regarding the scientific output, as provided for by the standards of “Babeş-Bolyai” University and of the Faculty of Letters. The oral and the written examination in the candidate</p>

	<p>assessment procedure will be conducted in English.</p> <p>In order to fill a position that requires teaching in a foreign language, the candidate must prove mastery of the respective language, both by submitting the required documents as part of the application file (Bachelor's degree attesting to the candidate's specialization in that language) and by taking the written and oral exam in that language before the assessment committee (English).</p>
<p>Position requirements</p>	<p><i>Teaching load</i>– 14 conventional hours</p> <ul style="list-style-type: none"> - preparation and teaching of courses (BA level practical courses in English for Specific Purposes included in the curriculum), in accordance with the competences concerned; -organizing the final and mid-term examinations for the respective courses during the exam sessions established by the faculty in accordance with existing regulations; - elaboration of the course outline, of the curriculum and of the course syllabi; - establishing and conducting office, tutoring, guidance and professional counseling hours for students. <p><i>Scientific research activity:</i></p> <ul style="list-style-type: none"> - elaboration and publication of articles and scientific studies in the field, in accordance with the indicators provided by the UBB Regulation in force; - participation in/ organization of cultural-scientific events within the department (conferences, symposia, workshops, peer-assessment sessions and instructions etc.); - participation in institutional, national and international scientific events in accordance with the individual and departmental research plan. <p><i>Administrative-civic activity:</i></p> <ul style="list-style-type: none"> - drafting promotional and dissemination materials; - participation in the editorial team of the annual volume of the department, dedicated to the various scientific events organized by the department;

<p>Description of the examination procedure</p>	<p>The candidates' competences are assessed based on the complete application file, by taking a written exam on a selected specialized topic, and by taking the oral exam which consists in delivering a teaching sample.</p> <p>Part 1: Evaluation of candidates' complete application files - In the evaluation of the scientific output, the quality of the publications and the candidate's contributions will be taken into account in relation to the requirements set out in the teaching load and the UBB standards, as well as to their relevance for the position. Furthermore, the candidate's teaching experience in the specialized field (English for Specific Academic Purposes) is taken into account, as well as the candidate's expertise in national and international research grants and projects.</p> <p>Part 2: Written exam - The assessment committee</p>

formulates the topic of the written exam in accordance with the indicated examination themes and bibliography. The candidates sit the written exam on **January 26th, 2023, 9.00 am, Faculty of Letters, no. 7 Horea Street, room 10.**

Part 3: Oral exam – The assessment committee selects the theme of the teaching sample to be delivered by the candidates, in accordance with the indicated examination themes and bibliography. On **January 24th, 2023, 12.00**, the assessment committee announces details related to the theme and the outline of the oral exam by publishing information on the web page of the Faculty of Letters and on the notice board of the Department of Foreign Languages for Specific Purposes (no. 7 Horea Street) and by email.

Candidates take the oral exam in turns, alphabetically, on **January 26th, 2023, starting time 12.00, Faculty of Letters, no. 7 Horea Street, room 10.** On **January 24th, 2023, 12.00**, the list of candidates organized alphabetically will be published on the web page of The Faculty of Letters, as well as on the notice board of the Department of Foreign Languages for Specific Purposes (no. 7 Horea Street). The maximum duration of the oral exam for each candidate is 30 minutes followed by a maximum 15-minute Q&A session with the members of the committee.

The evaluation of the complete application file, the written exam, and the oral exam **weigh equally** in the final grade granted in the individual evaluation sheet completed by each member of the assessment committee. The results of the competition for the position of assistant professor will be posted on the web page of the Faculty of Letters after the assessment committee completes their work.
