## THE ORGANISATION AND COURSE OF THE GRADUATION EXAMS AND OF THE RE-EVALUATION EXAMS AT UBB, DURING THE SUSPENSION OF FACE TO FACE DIDACTIC ACTIVITIES

## Addendum 6 to the Regulations regarding the students' professional activity (at BA and MA levels) within Babeş-Bolyai University, based on the European Credit Transfer and Accumulation System (ECTS)

- Approved by the UBB Senate Resolution No. 5937/16.04.2020 - Amended and re-published based on Senate Resolutions
No. 13355/21.09.2020 and No. 17906/14.12.2020 -

Considering the state of emergency in Romania, established by Decree No. 195/2020 of 16<sup>th</sup> March 2020, and the measures adopted at a national level to prevent the spread of SARS-CoV-2, as well as the resolutions of Babeş-Bolyai University regarding the suspension of didactic face-to-face activities and their online course, *The Regulations for the organisation and course of the BA and MA graduation exams* approved by the Senate Resolution No. 4415/9.03.2020 will be completed by the following provisions, applicable for the Bachelor's/ Master's graduation exams of July 2020 and September 2020, in case of no face-to-face teaching activities be allowed on a national level:

- 1. The exam sessions and the re-evaluations will take place according to the initial calendar put forward by faculties and approved by the Rector's Office for the 2019-2020 academic year.
- 2. Exams will be delivered online, through a platform chosen by the professor teaching that respective subject from the various platforms proposed and made available by the faculty and the university. Upon the teacher's initiative, online oral exams may be recorded, with the consent of students giving the exam, and in compliance with the personal data protection regulation. Students will be notified of the change in the form of evaluation or the structure of the grade established in the course syllabus allowing them sufficient time to submit their project papers or give the exams prior to the established deadlines.
- 3. For specialisations where the traineeship cannot be done within the current circumstances, this traineeship will be re-scheduled, without any fee, for the next

- academic year. Students in this situation will be considered as having promoted all exams, thus accumulating 30-x credits/semester, where x is the number of credits allocated to the traineeship. Therefore, the averages of students will be calculated without the grade and credits of the traineeship.
- 4. For final-year students, if the traineeship or the practical papers/ laboratory papers/ projects stipulated in the curriculum cannot be carried through within the current circumstances (and they cannot be replaced by computer modelling/ design/ data processing), upon the head of discipline and with the approval of the Faculty Council, they may be replaced by other online tasks which may lead to acquiring similar skills.
- 5. In the case of subject which include in their curricula practical or laboratory papers or projects that cannot be replaced by computer modelling, design, data processing, only knowledge taught at courses and/or seminars will be evaluated, and the practical activity or the activity in the laboratory can be carried through in the following academic year.
- 6. The teaching staff of the Faculty of Physical Education and Sports will prepare video material showing physical workout and training, which will be made available to students from all UBB faculties. In order to promote the discipline *Physical Education* and get the respective credits, students must practice these trainings at home.
- 7. Upon the adoption of the present addendum, the other provisions of the Regulations regarding the students' professional activity (Bachelor's and Master's level) at Babeş-Bolyai University, based on the European Credit Transfer and Accumulation System (ECTS) approved by Senate Resolution No. 24048 of 10.12.2019 will remain valid.
- 8. Once the national circumstances change, and they allow for the recommencement of face-to-face teaching activities, the provisions of the present addendum will cease to be valid, and the *Regulations regarding the students' professional activity* (Bachelor's and Master's level) at Babeş-Bolyai University, based on the European Credit Transfer and Accumulation System (ECTS) approved by Senate Resolution No. 24048 of 10.12.2019 will be fully applied.
- 9. Once the national situation will be modified and face to face didactic activities will be allowed to resume, the provisions of the present Addendum will cease to be in force, and the *Regulations regarding the students' professional activity (Bachelor's and Master's level) at Babeṣ-Bolyai University, based on the European Credit Transfer and Accumulation System (ECTS)* approved by the Senate Resolution No. 24048 of 10.12.2019 will be fully in place.
