



Decision No. 91 of 25/06/2024
on the approval of the Regulations governing fees
for the 2024-2025 academic year

Considering the Babes-Bolyai University Administrative Council Decision no. 8 730/14.06.2024,

Considering the positive recommendation of the Committee on Budget and Heritage,

Pursuant to art. 162 and 165 of the Charter of Babes-Bolyai University of Cluj-Napoca and of art. 18 letter e) of the Regulation on the Organisation and Operation of the Senate,

the Babes-Bolyai University Senate,
convened in a special session on 25 June 2024,
has decided that:

Art. 1. Addendum 1 to Senate Decision no. 38/18.03.2024 on the Regulation on Fees for admission, enrolment and completion of studies for the 2024-2025 academic year is hereby approved as follows:

- Addendum no. 1 - Admission processing fee for Romanian, EU, EEA and CH citizens is supplemented with a fee for the Public Health undergraduate degree in Romanian at the Faculty of Political, Administrative and Communication Sciences in the amount of 30 lei.
- Addendum no. 2 - Application fee for the admission competition for Romanian, EU, EEA and CH citizens is supplemented with a fee for the Public Health undergraduate degree in Romanian at the Faculty of Political, Administrative and Communication Sciences in the amount of 170 lei.
- Addendum no. 3 - Tuition fee for Romanian, EU, EEA and CH citizens is supplemented with a fee for the Public Health undergraduate degree in Romanian at the Faculty of Political, Administrative and Communication Sciences in the amount of 4,300 lei.

Art. 2. Addendum 1 as amended and supplemented by this Decision, shall be republished.

**Addendum 1 to Senate
Decision no. 38/18.03.2024**

Regulation governing the fees for admission, enrolment and completion of studies for the 2024-2025 academic year

- As amended and supplemented by SD no. 91/25.06.2024 -

- Art. 1.** This Regulation establishes the amounts, terms and payment of fees for admission, tuition, and graduation as well as the discount schemes for tuition fees for all levels and forms of study for Romanian citizens and those assimilated, as well as for foreigners.
- Art. 2.** Tuition fees for the master's level will equal at least the amount of fees established for the undergraduate level.
- Art. 3.** The new amounts of fees (rates) for admission, enrolment and completion of studies related to the 2024-2025 academic year will apply to first year students (undergraduate, master's and doctoral level), respectively to students who in the 2024-2025 academic year resume their studies or are required to pay the registration fee for the completion of studies exams.
- Art. 4.** Tuition fees are paid by students from Romania and other countries of the European Union, European Economic Area or the Swiss Confederation either in full or in instalments. The instalment payment facility works as follows:
- until confirmation of place for the first year students, respectively by October 15 for students from other years of study, at least 25% of the annual tuition fee must be paid;
 - by December 5, at least 50% of the annual tuition fee;
 - by March 15, at least 75% of the annual tuition fee;
 - by May 15, 100% of the annual tuition fee to be paid.
- Art. 5.** Tuition fees discounts established by the faculties are granted only to Romanian students and equivalent for undergraduate level -

full time and distance education (see Addendum 7), except for faculties granting the master's level special discounts (see Art. 9). Applications for tuition fee discounts will be submitted to the faculty secretariats within the first ten working days of the academic year. The tuition fee discount, depending on its amount, applies in all cases to the last and the penultimate instalment as appropriate.

Art. 6. For full payment of tuition fee until confirmation of place, first year students can be granted a 10% discount. This discount also applies to other years of study provided full payment of the tuition fee until October 15 for full time specialisations, respectively until October 31 for distance learning/ part time specialisations.

Art. 7. Exception from the provisions of art. 5 are the discounts granted for the 2nd degree programme at the same level within UBB covered by this article.

- a UBB students are eligible for fee discounts for the second degree programme pursued in parallel, discounts ranging between 25% and 50% of the annual tuition fee as established by the Faculty Council. UBB graduates who are enrolled in a second degree programme may be eligible for the same discounts.
- b Tuition fee discounts may be granted to a student for a single degree programme. If a student follows simultaneously two majors and one of them is distance learning/ part time learning, the tuition fee discount is granted for the specialisation in distance learning/ part time learning. In other cases, the discount is granted for the second specialisation.
- c Documents attesting to being enrolled in another degree programme at UBB, respectively UBB graduates, are filed in order to establish tuition discounts in the first ten working days of the academic year, with the discount application request. They must include a statutory declaration that the student does not and has never benefited from another similar discount simultaneously in another programme of studies within UBB.
- d The document attesting to their being enrolled in another degree programme must be issued in the first ten working days of the academic year and include an entry stating that the student has no overdue debts in relation to UBB.

Art. 8. Students allocated a budgeted place as a result of reclassification will be refunded the tuition fees paid upfront for that academic year.

Art. 9. Faculties are free to apply, upon request, the following special discounted tuition fees with prior approval of the Faculty Council: For undergraduate degree - full time education and distance education and master's degree - full time education and part-time education and doctoral degree:

- a the 25% discount of the tuition fee for members of the same family (spouse, parents, children or brothers/ sisters) who are students at the Faculty, enrolled in undergraduate or master's degree programmes, provided that everyone have paid the first two instalments of the tuition fee;
- b tuition fee exemption (100% discount) for orphans of both parents, under the age of 35, with a net monthly income lower than the national minimum wage;
- c tax exemption (100% discount) for students under the age of 35 covered by the special protection measure of placement under any of the forms defined by Law No 272/2004.
- d 50% discount for students with marked and severe functional limitations based on the medical documents submitted;
- e 50% tuition fee discount for orphans of one parent, under the age of 35, with a net monthly income lower than the national minimum wage;

Documentation required to obtain a reduction/exemption from the tuition fee for students who fall under art. 9, letters b and e, is:

- certificate attesting that the applicant is in foster care (where applicable);
- net income certificate required typically for the last 3 months;
- supporting documents issued by the Financial Administration regarding the net income obtained from authorised activities for all family members over the age of 18 (for example: letting, sole trader, family business, companies, capitalisation of tangible property of student: agricultural land, woodland, etc., according to the provisions of Law No. 227/2015 on the Tax Code).

Art. 10. Discounts are applied as stepped discounts and not accumulated discounts (see explanatory note) and are established for each academic year.

Art. 11. With prior approval from the Faculty Council, faculties are free to grant employees of Babeş-Bolyai University of Cluj-Napoca, upon submission of a written request addressed to the faculty, a discount of more than 50% of:

- a. the annual tuition fee for undergraduate level for maximum the normal duration of the specialisation pursued by an employee (3 or 4 years), in which case an amendment to the employment contract will be drawn up stipulating that the employee remains in the institution for a period of minimum 3 or 4 years (depending on the period for which tuition discount was approved) (see Addendum 10).
- b. the annual tuition fee for master's level, for maximum 2 years, in which case an amendment to the employment contract will be signed stipulating that the employee remains in the institution for a period of minimum 2 years (see Addendum 10).
- c. the annual tuition fee for doctoral level for maximum 3 years, in which case an amendment to the employment contract will be signed stipulating that the employee remains in the institution for a period of minimum 3 years from the public defence of the thesis (see Addendum 10). The discount does not apply to the fee for the public defence of the thesis.

Fixed-term employees in UBB cannot benefit from the provisions of this article.

Art. 12. Regulations for specific situations:

12.1. Withdrawal from education - undergraduate, master's, post-doctoral programmes, psycho-pedagogical programmes - Level I and Level II of the Department for Teacher Training (DPPD), doctoral programmes, is done following an application request approved by the faculty leadership or head of DPPD prior to enrolment or following enrolment.

- a. First year students, admitted on tuition will sign the learning agreement upon confirmation of place. If the student submits to the faculty secretariat a registered request to withdraw from studies, within the period of time since signing the agreement to the day preceding the beginning of the academic year, tuition fees (fares) will be fully refunded.
- b. With the exception of first year students, all students who request to withdraw from studies prior to the beginning of the academic year are entitled to a full refund of the tuition fee paid upfront for the remaining period after the date of withdrawal, by the end of the academic year, according to Article 4. point c and Article 12.1-point c.
- c. After the beginning of the academic year, for registered students attending degree programmes on tuition, regardless of the year of study, the tuition due is calculated according to the date of filing the request for withdrawal and in accordance with Art. 3 above, as follows:
 - If the withdrawal request is filed during the first semester, the tuition fee due will be 50%;
 - If the withdrawal request is filed during the second semester, the tuition fee will be due in full;

- These provisions are closely interrelated with the regulations governing the organisation of study groups, the establishment of teaching workloads and the funding of costs incurred.
- d. Net fee due at the time of withdrawal will be determined as the difference between the total fee payable and the total fee paid cumulatively from the beginning of the academic year to which any outstanding fees from previous academic years may be added.
- e. Refund of any amounts of tuition fees will be made only upon request submitted after the withdrawal.

12.2. Re-enrolment - undergraduate, master's degree, psycho-pedagogical programmes - Level I and Level II at DPPD, students will pay fees in instalments, as follows:

- a. re-enrolment cost in addition to any payments due from previous academic years of study except for outstanding exams will be paid before the start of the academic year the re-enrolment is made, within the deadlines set by the faculties for re-enrolled students (upon submission of the re-enrolment application);
 - b. the tuition (fee) for the academic year in which the re-enrolment is done, the tuition fees, respectively, as follows: fees for subjects not passed in previous years (outstanding exams) and any fees for courses in the subsequent years of study which the student requests to be included in the learning agreement to be paid in the course of the academic year before the start of the exam session for that semester, according to the terms established by the faculties.
- Students from Romania, other countries of the European Union, the European Economic Area or the Swiss Confederation will only pay, for the year of study to which they have re-enrolled, the fees pertaining to the exams they have not passed, which will be added to the tuition fee for the respective academic year and any fees pertaining to the subjects from the following years which the student wishes to include in the study agreement. Tuition fees may be paid by 15 October in full, subject to no discount, or in instalments, i.e. by 5 December for the first semester and by 15 May for the second semester.
 - Babeş-Bolyai University students, citizens from states that are not members of the European Union, the European Economic Area as well as the Swiss Confederation, enrolled on tuition and self-funded, will pay the amount of tuition fees (rates) in foreign currency established for the 2024-2025 academic year in accordance with Addendum no. 4.

12.3. Interruption of studies - undergraduate, master's level, psycho-pedagogical programmes - Level I and Level II of DPPD, doctoral studies, students must meet the

requirements resulting from the updating of the curricula, including those pertaining to changes in the tuition fee. The tuition fees payable by students enrolled on tuition who apply for interruption of studies is determined as follows:

- a. After the beginning of the academic year, for registered students attending degree programmes on tuition, regardless of the year of study, the tuition payable is calculated according to the date of filing the request for withdrawal and in accordance with Art. 3 above, as follows:
 - If the application for interruption of studies is submitted during the first semester the tuition fee payable will be 50%;
 - If the application for interruption of studies is submitted during the second semester the tuition fee will be due in full;
- b. Net fee payment at the time of interruption of studies is determined as the difference between the total fee payable and the total fee paid cumulatively from the beginning of the academic year to which any unpaid fees in previous academic years can be added.

12.4. Student academic mobility from other institutions on tuition places. Students who benefit from academic mobility will comply with the system established for the programme and year of study to which they were transferred. Students will pay the tuition established for the academic year in which the academic mobility was operated.

12.5. In the event of **shifts through redistribution from a place on tuition to a state funded place**, following admission to bachelor's, master's and doctoral programmes as a result of the withdrawal of candidates initially admitted on budgeted places or as a result of supplementing the number of state funded places, candidates are entitled to a tuition fee refund or refund of the instalment paid upon confirmation of place. A place is considered confirmed if the student pays in advance at least one instalment of the tuition fee and signs the learning agreement. Refunds are made based on the lists prepared by the faculty and do not require an application.

12.6. In the event of a **transfer from state-funded to tuition-based places**, students in years 2, 3, and 4 who are on a regular track **with no interruptions in their course of study** will pay the tuition fee established for their class.

12.7. Regardless of the year of registration, doctoral students on tuition places, including those who extended their period of studies, will pay for the **public defence of doctoral thesis** a fee corresponding to the academic year in which the thesis defence is due.

- 12.8. The doctoral student in extension of studies will pay the tuition fee only for the extended period (1 year or maximum 2 academic years), including for the semester in which the doctoral thesis is defended.

Art. 13. Fee (rate) for taking the exams established in Addendum no. 5

- 131.** Fee (rate) applies to graduates of Babeş-Bolyai University of Cluj-Napoca upon a new enrolment as follows:
- in case of failing in two consecutive sessions following enrolment (June, February) or only in one of them;
 - when the first registration occurs more than 3 years after graduation.
- 132.** Fee paid to apply for an examination entitles the student to sit for the exams in two consecutive sessions (June, February) of the same academic year. Fee related to the graduation exam covers both examinations.

Art. 14. For graduates of higher education institutions other than the Babeş-Bolyai University of Cluj-Napoca, the **costs pertaining to applications to sit for the graduation exams, diploma exam, respectively master's thesis defence** may fall within the range established in Addendum no. 5 and its **double**.

Art. 15. For self-funded tuition paying students of Babeş-Bolyai University, citizens from **states that are not members of the European Union, of the European Economic Area as well as of the Swiss Confederation**, the amount of tuition fees (rates) is established in foreign currency for the 2024-2025 academic year in accordance with Addendum no. 4. The following regulations will be taken into consideration:

- 15.1.** A fee of 50 Euro will be paid for processing the admission file, regardless of the level of study or form of education for which the file is submitted.
- 15.2.** For full time students (undergraduate, master's or doctorate degree):
- a. Fees are paid throughout the duration of the academic year of:
 - 9 months for the years of study in which the curricula do not provide a Training course or the Training provided in the curriculum takes place throughout the semester and not as a distinct period of time.
 - 10 months for the years of study in which the curricula provide a Training discipline over a period distinct from the teaching activities.
 - b. Fees may be paid in full by October 15 without benefiting of any discount, or in instalments, according to art. 4 of this decision.
 - c. Fees set out in Addendum no. 4 do not cover costs of accommodation, respectively meals.
- 15.3.** For the undergraduate, master's and doctoral degrees - part time education and other programmes of study, according to Addendum no. 4, organised under the law for each year of study, fees are paid in advance for three months, at the amount

set for full time education, according to Addendum no. 4.

Fees thus determined shall be paid in full prior to the first session of exams.

15.4. For the bachelor's, master's graduation exam and doctoral dissertation defence during the 2024-2025 academic year the amount of fees is provided in Addendum no. 6. Any other personal expenses will be sustained by those concerned (including accommodation, meals and transportation).

Art. 16. The current decision, upon its coming into effect, will supersede the Decision no. 12/20.02.2023 of the Babeş-Bolyai University Senate, as well as any related addenda.

Art. 17. Addenda no. 1, 2, 3, 4, 5, 6, 7, 8, 9, and 10 are an integral part of this decision.

Art. 18. The Administration Council must provide the dean's office and leadership of CFCIDFR (Centre for Continuing education, distance learning and part-time learning) standard forms of learning agreements in accordance with the provisions of this decision.

Art. 19. For failure to pay in due time the fees established by this decision a penalty of 0.04% is calculated for each day of delay from the due date of the payment obligation until actual payment.

Art. 20. The payment methods for tuition fees are:

- cash/bank card, at the cash desks of the faculties:
- online, via AcademicInfo (fees section).

Art. 21. Payment for all subjects taken and not passed in previous years (outstanding exams) will be made no later than one week before the exam session for each semester.

Explanatory Note to art. no 9 of above Regulation:

1st example:

Student, undergraduate level, who studies at Faculty X, the first specialisation A (2nd year) and the second specialisation B (first year). Pays tuition for the 2nd specialisation in advance and in full (until 15 October 2021).

*The **annual tuition fee** for specialisation B:*

2,500 lei (see Addendum no. 3)

***Discount for the 2nd specialisation: 50%** (see Addendum no. 7)*

***Discount for upfront payment and full payment: 10%** (see art. 5 of the above decision)*

*The **fee due** for specialisation B = $(1-0.10) \times (1-0.50) \times 2,500 = 0.90 \times 0.50 \times 2,500 = 1,125$ lei*

2nd example:

Student, undergraduate level, graduate of Babeş-Bolyai University of Cluj-Napoca, is enrolled in a second specialisation at Faculty Y (1st year of study). Pays tuition for the 2nd specialisation in advance and in full (until 15 October 2021).

*The **annual tuition fee** for the specialisation:*

***2,400 lei** (see Addendum no. 3)*

*Tuition **discount** for being an **UBB graduate**: 25% (see Addendum no. 7)*

***Discount for upfront payment and full payment**: 10% (see art. 5 of the above decision)*

***Tuition fee payable** = $(1-0.10) \times (1-0.25) \times 2,400 = 0.90 \times 0.75 \times 2,400 = 1,620$ lei.*

This Regulation and its addenda shall be approved by Senate Decision no. 38/18.03.2024 and shall take effect beginning with the 2024-2025 academic year.

Art. 1. Individual labour contract provisions no. / to be filled with the terms of this addendum.

Art.2. For training purposes, the employee attends courses at the Faculty of
....., specialisation, level of studies

Art.3. The employer undertakes to grant the employee a reduction of 50% of the tuition fee for the duration of the studies for the level of studies attended.

Art. 4. The employee undertakes to work for the employer after graduation for a time period equal to that for which they benefited from the annual tuition fee deduction.

Art. 5. The employee shall bear full payment of the tuition fee for the period they have not worked of the time span indicated in art. 4, where the individual employment contract is terminated on the following grounds:

- a) Sentencing to execution of a custodial sentence, from the date of the final court judgement (Article 56, letter f of the Labour Code);
- b) Withdrawal by the authorities or authorised bodies of permits, authorisations or certificates required by the profession, from the date of withdrawal (article 56, letter g of the Labour Code);
- c) Prohibiting the practice of profession or duties as a safety measure or as complementary punishment, from the date of the final court decision which ordered the ban (article 56, letter h of the Labour Code);
- d) Disciplinary sanctions for serious misconduct or repeated violations of the rules of labour discipline or of those set by the individual employment contract, collective labour agreement or internal rules (Article 61, letter a. of the Labour Code);
- e) Preventive detention for a period exceeding 30 days, under the Code of Criminal Procedure (Article 61, letter b of the Labour Code);
- f) The employee is professionally unfit for their designated job (61, letter d of the Labour Code);
- g) The resignation of the employee (Article 81 of the Labour Code).
