Addendum 1 to the ACR No. 14115/28.09.2020 amended in ACR No. 14705/6.10.2020

CONDITIONS FOR THE SUSPENSION OF DIDACTIC ACTIVITIES REQUIRING STUDENTS' PHYSICAL PRESENCE

Considering that educational activities at Babeş-Bolyai University take place in different locations around Cluj-Napoca/extensions from other towns, should there be a case/several cases of COVID-19 infection, the situation will be analysed by DPH (the Department for Public Health) together with the university governing bodies. In each case, within max. 24 hours, there will be an epidemiological investigation run by the DPH epidemiologist, in collaboration with the doctor from the university medical office, if there is such an entity, with the view to establishing the direct contacts in the community.

According to the joint Order of the Ministries of Education and Research and, respectively, of Health, No. 5487/1494/2020, with the amendments and supplementations of the joint OM No. 5650/1670/2020, didactic activities requiring students' physical presence (onsite) are suspended in the following situations:

I. Spread of COVID-19 among students:

I.1. Upon the emergence of a case in a study group within a location - all onsite didactic activities are suspended for 14 days, moving into the online, for the respective group. If in a room 2 (two) or more study groups carry out activities, the didactic activities involving physical presence will be suspended only in the case of the study group where the COVID-19 case was confirmed; the room will be cleaned, disinfected and ventilated, and students from other groups will carry out their activities as usual.

I.2. Upon the emergence of three simultaneous cases within the same location - based on epidemiological investigations, onsite didactic activities may be suspended for 14 days from the first day of the most recent case, thus moving into the online, for the entire location.

I.3. Upon the emergence of three simultaneous cases within the same location - based on epidemiological investigations, onsite didactic activities may be suspended for 14 days from the first day of the most recent case, thus moving into the online, for the entire location. Doctoral studies will also be suspended.

II. COVID-19 spread among teaching staff:

In the case of COVID-19 infections among the teaching staff, the latter must inform the leadership of the higher education institution who will in its turn inform the DPH. DPH will investigate, analyse the situation within the higher education institution together with the latter's leadership, and decide together upon the necessary measures to be taken.

Didactic activities involving physical presence of students in higher education institutions, within conditions of sanitary safety, will be organised upon a university senate resolution, after the positive notice of DPH certifying that conditions of epidemiological safety of the didactic activities are complied with.

Based on the epidemiological situation within the county, DPH may recommend the higher education institution to prolong the partial/total temporary suspension of didactic activities involving students' physical presence in the education institution.
