**Addendum to the ACR No. 9771/16<sup>th</sup> July 2020**

**Procedure for the application of methodological scientific paper for the conferral of the didactical qualification level I in pre-university education, during the pandemic**

In compliance with the stipulations of OM No. 3850/2017 regarding the approval of the Methodology for initial training of teaching staff in pre-university education (with the subsequent alterations and supplements: OM No. 4129/2018) and in compliance with the stipulations of OM No. 5561/07.10.2011 regarding the approval of the Methodology for continuous training of teaching staff in pre-university education (with the subsequent alterations and supplements: OM No. 3129/2013, OM No. 5397/2013, OM No. 3240/2014, OM No. 5439/2015, OM No. 5386/2016, OM No. 3367/2017);

Considering the state of emergency in Romania given by Decree No. 195/2020 of 16<sup>th</sup> March 2020, the subsequent measures adopted nationally for the prevention of the spread of SARS-CoV-2, the Babeş-Bolyai University resolutions regarding the suspension of didactic face-to-face activities and their transfer online, as well as the GEO No. 58/23.04.2020 on the measures taken for the good functioning of the educational system, the Regulation of the Department for Didactic Staff Training regarding the organisation of psycho-pedagogical training programmes for the conferral of the certificate for teaching and the conferral of the didactical qualification level I at Babeş-Bolyai University - the Regulation will be added the following provisions to be applied upon the defence of a methodological scientific paper for the conferral of the didactical qualification level I, series 2019-2021, if the national situation will not allow for the resuming of face-to-face activities, as follows:

1. With the view to defending the methodological scientific paper, the candidate will submit the former on an electronic platform that allows for the safe sending/uploading and stocking of documents in electronic format, containing the following:
  - a. Scientific coordinator written notice;
  - b. The methodological scientific paper;
  - c. The candidate's declaration of authenticity (affidavit), stipulating that:
    - i. The paper was personally written by and fully belongs to the candidate;
    - ii. No sources were used other than those mentioned in the bibliography;
    - iii. No text, data or graphic elements were taken from other papers or from other sources without them being quoted and without the mention of the source, including case when the course are other papers written by the candidate;
    - iv. The paper has not been used in other examination and competition contexts.
2. The secretary's office of the Department for Teaching Staff Training logs the sent paper and sends the document logging number to the candidate, via e-mail.
3. The hard copy of the paper, together with the scientific coordinator's notice and the affidavit will later be archived, after the public defence of the paper, transmitted to the secretary's office of the Department for Teaching Staff Training through the scientific coordinator, in due time.
