DECISION

on the modification of the teaching approach at the Faculty of Law

Considering the Joint Order no. 5 338/2015/2021 of the Minister of Education and the Minister of Health, the Administrative Council Decisions no. 10 753/14.09.2021, no.11 214/20.09.2021 and the University Senate Decision no. 117/23.09.2021,

Having regard to the request submitted by the Faculty of Law no. 660/12.10.2021,

The Administrative Council of Babeş-Bolyai University, following the electronic vote cast on 12 October 2021,

DECIDES:

Art. 1. The modification of the teaching approach for the Criminal and Forensic Sciences master's degree specialisation between 12 to 24 October 2021, from face to face teaching (approach one) to online teaching (approach 3) is hereby approved.

Art. 2. The modification of the teaching approach for the Legal terminology course in Hungarian language, year I, between 12 to 24 October 2021, from face to face teaching (approach one) to online teaching (approach 3) is hereby approved.

Art. 3. The continuation of face-to-face teaching activities for third-year student groups 309 and 313 in accordance with the provisions of art. 4 of University Senate Decision No. 117/23.09.2021 is hereby approved: *"asymptomatic students who have been vaccinated against SARS-CoV-2 virus and have had at least 10 days since the completion of the entire vaccination scheme, as well as asymptomatic students who have tested positive for SARS-CoV-2 virus infection in the last 180 days but have had more than 14 days since the date of the positive test"* between 12 to 24 October 2021. The other students will engage in online teaching activities with the groups.

Art. 4. The continuation of face-to-face teaching activities in courses with compulsory attendance for first-year students in accordance with the provisions of art. 4 of University Senate Decision No. 117/23.09.2021 is hereby approved: *“asymptomatic students who have been vaccinated against SARS-CoV-2 virus and have had at least 10 days since the completion of the entire vaccination scheme, as well as asymptomatic students who have tested positive for SARS-CoV-2 virus infection in the last 180 days but have had more than 14 days since the date of the positive test”* between 12 to 24 October 2021. Face-to-face activities as well as an online or hybrid activities will be provided.

Art. 5. The continuation of face-to-face teaching activities for first-year student group 109 in accordance with the provisions of art. 4 of University Senate Decision No. 117/23.09.2021 is hereby approved: *“asymptomatic students who have been vaccinated against SARS-CoV-2 virus and have had at least 10 days since the completion of the entire vaccination scheme, as well as asymptomatic students who have tested positive for SARS-CoV-2 virus infection in the last 180 days but have had more than 14 days since the date of the positive test”* between 12 to 24 October 2021. The other students will engage in online teaching activities with the groups.

Art.6. The continuation of the instructional activities for third-year students in series 2 of the Civil Law. Special contracts course (series 2) in accordance with the provisions of art. 4 of University Senate Decision No. 117/23.09.2021 is hereby approved: *“asymptomatic students who have been vaccinated against SARS-CoV-2 virus and have had at least 10 days since the completion of the entire vaccination scheme, as well as asymptomatic students who have tested positive for SARS-CoV-2 virus infection in the last 180 days but have had more than 14 days since the date of the positive test,”* considering that this course is conducted in the hybrid approach.
