THE ORGANISATION AND THE COURSE OF THE SPECIAL INSPECTION FOR ACQUIRING THE DIDACTICAL QUALIFICATION AT UBB, DURING THE PERIOD OF CANCELLATION OF FACE-TO-FACE DIDACTIC ACTIVITIES

Addendum to the Regulations of the Department for Training Teaching Staff regarding the organisation of programmes of psychopedagogical training for acquiring the didactical qualification levels II and I at Babes-Bolyai University

- approved by the UBB Senate during the 4th May 2020 assembly -

In compliance with the *OM no. 3850/2017 regarding the approval of the Methodology for the initial training of teaching staff in school education* (with the subsequent alterations and addenda: *OM no. 4129/2018*) and in compliance with the *OM no. 5561/07.10.2011 on approving the Methodology for continuous education of teaching staff for school education* (with the subsequent alterations and addenda: *OM no. 3129/2013, OM no. 5397/2013, OM no. 3240/2014, OM no. 5439/2015, OM no. 5386/2016, OM no. 3367/2017*)

and considering the state of emergency within the country, based on *Decree no. 195/2020* of 16th March 2020, the subsequent measures adopted nationally against the spread of SARS-CoV-2, the resolutions of Babeş-Bolyai University regarding the cancellation of face-to-face didactic activities and their course online, as well as considering the *GEO no. 58/23.04.2020* regarding the measures taken for the good functioning of the education system, the Regulations of the Department for Training Teaching Staff regarding the organisation of programmes of psychopedagogical training for acquiring the didactical qualification levels II and I at Babeş-Bolyai University will be followed by addenda with the following provisions to be applied during special inspections for acquiring I level didactical qualification, 2018-2020 series, if the national circumstances will not allow for the face-to-face activities to take their course again; as such:

1. The acquisition of the didactical qualification level I for the 2018-2020 series will take place in compliance with the provisions of GEO no. 58/23.04.2020, regarding the measures taken for the good functioning of the education system: "Art. 8. By derogation from the provisions of article 242, par. (5), letters b) and d) from the National Education

Law no. 1/2011 with the subsequent alterations and addenda, level I, 2018-2020 series, can be acquired by the teaching staff with a seniority of at least 4 years from acquiring level II within the department, by passing two current school inspections, divided over those 4 years, where the maximum score was granted and the methodical scientific paper was defended in front of a commission, which can be done online, too, according to the methodology of the Ministry of Education and Research".

- 2. In order to acquire the didactical qualification level I, the special inspection that was to be carried on within the school and include the attendance to four didactical activities carried on by a teaching member of the staff, and their subsequent analysis is suspended. The inspection will be replaced by the proof of promotion by the teaching member of the staff of two current school inspections, spread over 4 years, and which resulted in the maximum score. This proof is issued by the school based on the recordings in the inspection register of the respective school, and is signed by the school's principal or by the district school inspectorate.
- 3. The defence of the methodical scientific paper will be done online, in front of a commission appointed and approved by the ministry, in the presence of the respective school's principal or vice-principal, through a platform approved by the commission that allows for the transmission, simultaneous (*live*) reception and the recording of the audiovisual content. The defence session will be in compliance with all of the formal elements according to current regulations: the candidate will defend their methodical scientific paper, the scientific coordinator will present the paper review, the members of the commission will express their viewpoints on the presented paper, they will communicate and record the scores in the report.
- 4. The online defence of the methodical scientific paper is fully recorded and archived by the president of the commission. Prior to this, the participants' consent to record will be granted.
- 5. Once the online defence is concluded, the president of the commission will draft a written report granting level I didactical qualification. This report will be read in front of the members of the commission, who will give consent and sign it, together with the school principal for conformity.
- 6. The proof of the teacher's promotion of the two current school inspections issued by the school, the written report granting level I of didactical qualification, the reviewing assessment written and signed by the scientific coordination and the methodical scientific paper written by the candidate will be submitted in due time to the secretary's office of the *Department for Training Teaching Staff*, considering the observations of the respective ministry regarding the calendar of the activities for acquiring level I didactical qualification.

When the national circumstance will be changed and will allow for the face-to-face activities to take place, the provisions of the present addendum will cease to be valid, and the Regulations of the Department for Training Teaching Staff regarding the organisation of programmes of psychopedagogical training for acquiring the didactical qualification levels II and I at Babeş-Bolyai University will be fully applied.
